

**Invitation to Bid for**

**Construction of National Child Development Center**

**San Jose, Camarines Sur**

1. **The LGU – San Jose, Camarines Sur, through the Trust Fund C/Y 2015 intends to apply the total sum of Two Million Four Hundred Fifty Three Thousand Three Hundred Seventeen Pesos and 85/100 (Php 2,453,317.85) the Approved Budget for the Contract (ABC) to payments under the contract for Construction of National Child Development Center of this municipality. Bids received in excess of the ABC shall be automatically rejected at bid opening.**
2. **The Local Government Unit of San Jose now invites bids for Construction of National Child Development Center at San Jose, Camarines Sur with the following scope of works such as; I) Mobilization/Temporary Facilities/Demobilization, II) Earthworks, III) Concreting Works (includes ramp on fill) IV) Formworks, V) Reinforcing Steel Bars, VI) Masonry Works, VII) Doors and Windows, VIII) Steel Works, IX) Roofing Works, X) Carpentry Works, XI) Painting Works, XII) Tile Works, XIII) Electrical Works, XIV) Plumbing and Sanitary Works, XV) CHB Septic Vault & Catch Basin, XVI) Others. Completion of the Works is required 90 Calendar Days. Bidders should have completed, within ten (10) years from the date of submission and receipt of bids, a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in.**
3. **Bidding will be conducted through open competitive bidding procedures using non-discretionary pass/fail criterion as specified in the Implementing Rules and Regulations (IRR) of Republic Act 9184 (RA 9184), otherwise known as the “Government Procurement Reform Act”.**  
  
**Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least seventy five percent (75%) interest or outstanding capital stock belonging to citizens of the Philippines.**
4. **Interested bidders may obtain further information from LGU-San Jose Bids and Awards Committee and inspect the Bidding Documents at the address given below from 8:00 am to 5:00 pm, Monday to Friday excluding holidays.**
5. **A complete set of Bidding Documents may be purchased by interested Bidders on October 14, 2015 – November 3, 2015 from the address below and upon payment of a nonrefundable fee for the Bidding Documents in the amount of P 5,000.00.**
6. **The Procuring Entity intends to limit the Pre-Bid Conference to Bidders who have purchased the Bidding Documents;**

**The Local Government Unit of San Jose will hold a Pre-Bid Conference on October 21, 2015 at 8:30 A.M. at Mayor’s Office, 2nd floor Municipal Hall Building, San Jose, Camarines Sur, which shall be open to all interested parties.**

7. **Bids must be delivered to the address below on or before 8:00 A.M., November 3, 2015 at BAC Office, 2<sup>nd</sup> floor Municipal Building, San Jose, Camarines Sur. All bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in ITB Clause**

Bids will be opened in the presence of the bidders' representatives who choose to attend at the address below. Late bids shall not be accepted.

8. The *LGU – San Jose, Camarines Sur* reserves the right to accept or reject any bid, to annul the bidding process, and to reject all bids at any time prior to contract award, without thereby incurring any liability to the affected bidder or bidders.
