

**Invitation to Bid for**

***Concreting of Core Local Access Road***

***Sitio Ligao, Boclod Road Section, San Jose, Camarines Sur***

1. **The LGU – San Jose, Camarines Sur, through the ADM (Assistance to Disadvantage Municipality) Fund 2017 intends to apply the total sum of One Million Eight Hundred Thirty Seven Thousand Eight Hundred Seventy Four Pesos (Php 1,837,874.00) being the Approved Budget for the Contract (ABC) to payments under the contract for Concreting of Core Local Access Road at Sitio Ligao, Boclod Road Section, San Jose, Camarines Sur. Bids received in excess of the ABC shall be automatically rejected at bid opening.**
2. **The Local Government Unit of San Jose now invites bids for Concreting of Core Local Access Road at Sitio Ligao, Boclod Road Section, San Jose, Camarines Sur with the following scope of works such as; 100) Clearing/Grubbing, 105) Subgrade Preparation, 202) Aggregate Sub-Base Course, 311) PCCP, 104) Embankment; SLOPE PROTECTION: A.) Earthworks/Structure Excavation; a-1) Excavation; B) Grouted Riprap w/ RCPC, SPL1) Construction Safety and Health, SPL2) Rental of Bunkhouse/Field Office, SPL3) Project Billboard, SPL4) Mobilization/Demobilization. Completion of the Works is required 90 Working Days.**
3. **Bidding will be conducted through open competitive bidding procedures using non-discretionary pass/fail criterion as specified in the Implementing Rules and Regulations (IRR) of Republic Act 9184 (RA 9184), otherwise known as the “Government Procurement Reform Act”.**

Bidding is restricted to Filipino citizen or 75% Filipino-owned partnership, corporation, cooperative or joint venture and must have an experience of having completed, within a period of ten (10) years from the date of submission and receipts of bids, at least one (1) contract that is similar to the contract to be bid costing at least 50% of the ABC.

4. **A complete set of Bidding Documents may be purchased by interested Bidders on *May 25, 2017 – June 14, 2017* from the address below and upon payment of a nonrefundable fee for the Bidding Documents in the amount of **P 5,000.00.****

It may also be downloaded free of charge from the website of the PhilGEPS and the website of the Procuring Entity, provided that bidders shall pay the non-refundable fee for the bidding documents not later than the submission of their bids.

5. **Bids must be delivered to the address below on or before *8:00 A.M., June 14, 2017* at *Assessor’s Office/BAC Office, Ground Floor Municipal Building, San Jose, Camarines Sur.* All bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in ITB Clause**

Bids will be opened in the presence of the bidders’ representatives who choose to attend at the address below. Late bids shall not be accepted.
