

## Invitation to Bid for

### ***Construction of Communal Public Toilet***

***Adiangao, San Jose, Camarines Sur***

1. **The LGU – San Jose, Camarines Sur**, through the **BUB-DOH Fund C/Y 2017** intends to apply the total sum of **Eight Hundred Eighty Thousand Pesos (Php 880,000.00)** the Approved Budget for the Contract (ABC) to payments under the contract for **Construction of Communal Public Toilet at Barangay Adiangao of this municipality**. Bids received in excess of the ABC shall be automatically rejected at bid opening.
  2. The **Local Government Unit of San Jose** now invites bids for **Construction of Communal Public Toilet at Barangay Adiangao, San Jose, Camarines Sur with the following scope of works such as: I.) Clearing/Leveling of Construction Site, A) Building: I.)Excavation for Structure, II) Concrete Works, III) Masonry Works, IV )Roof and Roof Framing Works, V) Ceiling Works (Outside Ceiling Only), VI) Flooring and Steel Works, VII) Doors and Windows, VIII) Sanitary/Plumbing & Toilet Accessories, IX) Tile Works, X) Electrical Works; B.) Construction of Septic Tank (1.50Mx3.75Mx1.75M); I) Excavation for Structure, II) Masonry Works, III) Concrete Works, SPL1) Additional Transportation Charge of Materials from Supplier to Construction Site, SPL2) Construction Safety and Health/Billboard, SPL3) Rental of Bunkhouse, SPL4) Mobilization/Demobilization**. Completion of the Works is required **60 Calendar Days**. Bidders should have completed, within ten (10) years from the date of submission and receipt of bids, a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in.
  3. Bidding will be conducted through open competitive bidding procedures using non-discretionary pass/fail criterion as specified in the Implementing Rules and Regulations (IRR) of Republic Act 9184 (RA 9184), otherwise known as the “Government Procurement Reform Act”.
- Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least seventy five percent (75%) interest or outstanding capital stock belonging to citizens of the Philippines.
4. Interested bidders may obtain further information from **LGU-San Jose Bids and Awards Committee** and inspect the Bidding Documents at the address given below from **8:00 am to 5:00 pm, Monday to Friday excluding holidays**.
  5. A complete set of Bidding Documents may be purchased by interested Bidders on **August 11-18, 2017** from the address below and upon payment of a nonrefundable fee for the Bidding Documents in the amount of **P 1,000.00**.
  6. Bids must be delivered to the address below on or before **8:00 A.M., August 18, 2017 at BAC Office/Assessor’s Office, Municipal Building, San Jose, Camarines Sur**. All bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in ITB Clause
  7. Bid opening shall also be held on **August 18, 2017, 8:30 AM and onwards at Assessor’s Office/BAC Office** of this municipality. Bids will be opened in the presence of the bidders’ representatives who choose to attend at the address below. Late bids shall not be accepted.
