

Invitation to Bid for

Construction of Waste Water Treatment Facilities, Sanitary Pit & Materials Recovery Facilities

Infirmary Hospital/RHU, Boclod, San Jose, Camarines Sur

1. **The LGU – San Jose, Camarines Sur**, through the **20% Economic Development Fund 2017** intends to apply the total sum of **Two Hundred Twenty Three Thousand Thirty Four Pesos and 44/100 (Php 223, 034.44)** being the Approved Budget for the Contract (ABC) to payments under the contract for the **Construction of Waste Water Treatment Facilities, Sanitary Pit and Materials Recovery Facilities at Infirmary Hospital/RHU, Boclod, San Jose, Camarines Sur**. Bids received in excess of the ABC shall be automatically rejected at bid opening.
2. The **Local Government Unit of San Jose** now invites bids for the **Construction of Waste Water Treatment Facilities, Sanitary Pit & Materials Recovery Facilities at Infirmary Hospital/RHU, Boclod, San Jose, Camarines Sur with the following scope of works such as; A) Construction of Waste Water Treatment Facilities: I) Clearing/Structure Excavation & Chipping Works, II) Masonry & Concrete Works, III) Embankment; B) Construction of 2 Units Sanitary Pit (1.40x3.20x2m): I) Structure Excavation, II) Concrete & Masonry Works, III) Hauling (Disposal of Excavated Materials); C) Establishment of Materials Recovery Facilities: I) Concrete & Steel Works, SPLI) Mobilization/Demobilization, SPLII) Construction Safety & Health**. Completion of the Works is required **45 Working Days**.
3. Bidding will be conducted through open competitive bidding procedures using non-discretionary pass/fail criterion as specified in the Implementing Rules and Regulations (IRR) of Republic Act 9184 (RA 9184), otherwise known as the “Government Procurement Reform Act”.

Bidding is restricted to Filipino citizen or 75% Filipino-owned partnership, corporation, cooperative or joint venture and must have an experience of having completed, within a period of ten (10) years from the date of submission and receipts of bids, at least one (1) contract that is similar to the contract to be bid costing at least 50% of the ABC.

Interested bidders may obtain further information from **LGU-San Jose Bids and Awards Committee** and inspect the Bidding Documents at the address given below from **8:00 am to 5:00 pm, Monday to Friday excluding holidays**.

4. A complete set of Bidding Documents may be purchased by interested Bidders on **December 7-14, 2017** from the address below and upon payment of a nonrefundable fee for the Bidding Documents in the amount of **P 500.00**.

It may also be downloaded free of charge from the website of the PhilGEPS and the website of the Procuring Entity, provided that bidders shall pay the non-refundable fee for the bidding documents not later than the submission of their bids.

5. Bids must be delivered to the address below on or before **8:00 A.M., December 14, 2017 at Assessor’s Office/BAC Office, Ground Floor Municipal Building, San Jose, Camarines Sur**. All bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in ITB Clause.
