Repair & Improvement of Comfort Room (Cultural Center)

1. **The LGU – San Jose, Camarines Sur**, through the **Supplemental Fund C/Y 2015** intends to apply the total sum of **Two Hundred Ninety Four Thousand Three Hundred Fifty Five Pesos and 43/100 (Php 294,355.43)** being the Approved Budget for the Contract (ABC) to payments under the contract for **Repair and Improvement of Comfort Room at Cultural Center of this municipality**. Bids received in excess of the ABC shall be automatically rejected at bid opening.
2. The **Local Government Unit of San Jose** now invites bids for **Repair and Improvement of Comfort Room at Cultural Center, San Juan, San Jose, Camarines Sur with the following scope of works such as; I) Chipping of Concrete, Removal of Existing CHB Partition Wall & Excavation Works, II) Concrete Works, III) Tiles & Masonry Works, IV) Embankment, V) Plumbing Works, VI) Carpentry Works (Doors, Ceilings, Cabinets), VII) Painting Works**. Completion of the Works is required **45 Calendar Days**. Bidders should have completed, within ten (10) years from the date of submission and receipt of bids, a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in.
3. Bidding will be conducted through open competitive bidding procedures using non-discretionary pass/fail criterion as specified in the Implementing Rules and Regulations (IRR) of Republic Act 9184 (RA 9184), otherwise known as the “Government Procurement Reform Act”.

Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least seventy five percent (75%) interest or outstanding capital stock belonging to citizens of the Philippines.

4. Interested bidders may obtain further information from **LGU-San Jose Bids and Awards Committee** and inspect the Bidding Documents at the address given below from **8:00 am to 5:00 pm, Monday to Friday excluding holidays**.
5. A complete set of Bidding Documents may be purchased by interested Bidders on **July 30, 2015 – August 6, 2015** from the address below and upon payment of a nonrefundable fee for the Bidding Documents in the amount of **P 500.00**.
6. Bids must be delivered to the address below on or before **8:00 A.M., August 6, 2015 at BAC Office, 2nd floor Municipal Building, San Jose, Camarines Sur**. All bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in ITB Clause

Bids will be opened in the presence of the bidders' representatives who choose to attend at the address below. Late bids shall not be accepted.

7. The **LGU – San Jose, Camarines Sur** reserves the right to accept or reject any bid, to annul the bidding process, and to reject all bids at any time prior to contract award, without thereby incurring any liability to the affected bidder or bidders.
