1. **The LGU – San Jose, Camarines Sur**, through the **BUB-BFAR C/Y 2015** intends to apply the total sum of **One Million Four Hundred Seventy Thousand Three Hundred Forty Five Pesos and 47/100 (Php 1,470,345.47)** the Approved Budget for the Contract (ABC) to payments under the contract for **Construction of Potable Water System at Barangay Adiangao, San Jose of this municipality**. Bids received in excess of the ABC shall be automatically rejected at bid opening.
2. The **Local Government Unit of San Jose** now invites bids for **Construction of Fish Trading Center at Sitio Talisay, Dolo, San Jose, Camarines Sur with the following scope of works such as; A.) Main Building I) Structure Excavation, II) Reinforced Concrete, III) Embankment, IV) Masonry Works, V) Painting Works, VI) Electrical Works, VII) Plumbing Works, B)Septic Tank, Distribution box & Soak Way I.) Structure Excavation, II) Reinforced Concrete, C) Billboard**. Completion of the Works is required **45 Calendar Days**. Bidders should have completed, within ten (10) years from the date of submission and receipt of bids, a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in.
3. Bidding will be conducted through open competitive bidding procedures using non-discretionary pass/fail criterion as specified in the Implementing Rules and Regulations (IRR) of Republic Act 9184 (RA 9184), otherwise known as the “Government Procurement Reform Act”.

Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least seventy five percent (75%) interest or outstanding capital stock belonging to citizens of the Philippines.

4. Interested bidders may obtain further information from **LGU-San Jose Bids and Awards Committee** and inspect the Bidding Documents at the address given below from **8:00 am to 5:00 pm, Monday to Friday excluding holidays**.
5. A complete set of Bidding Documents may be purchased by interested Bidders on **October 22, 2015 – November 10, 2015** from the address below and upon payment of a nonrefundable fee for the Bidding Documents in the amount of **P 5,000.00**.
6. **The Procuring Entity intends to limit the Pre-Bid Conference to Bidders who have purchased the Bidding Documents;**

The **Local Government Unit of San Jose** will hold a Pre-Bid Conference on **October 29, 2015 at 8:30 A.M. at Mayor’s Office, 2nd floor Municipal Hall Building, San Jose, Camarines Sur**, which shall be open to all interested parties.


