

**Invitation to Bid for**

**Construction of Talisay Port Warehouse (Bodega) Phase 2**

*San Jose Port, Dolo, San Jose, Camarines Sur*

1. The **LGU – San Jose, Camarines Sur**, through the **Supplemental Budget C/Y 2015** intends to apply the total sum of **One Million One Hundred Seventy Eight Thousand Seven Hundred Fifty Five Pesos and 33/100 (Php 1,178,755.33)** the Approved Budget for the Contract (ABC) to payments under the contract for **Construction of Talisay Port Warehouse (Bodega) Phase 2 at San Jose Port of this municipality**. Bids received in excess of the ABC shall be automatically rejected at bid opening.
2. The **Local Government Unit of San Jose** now invites bids for **Construction of Talisay Port Warehouse (Bodega) Phase 2 at San Jose Port, Dolo, San Jose, Camarines Sur with the following scope of works such as; I) Mobilization, II) Safety and Health A.) Old Building, I) Breaking of CHB Wall & Removal of Steel Door, II) Masonry Works, III) Doors and Windows, IV) Painting Works, B.) Annex Building, I) Electrical Works, C) New Building, I) Structure Excavation, II) Reinforced Concrete, III) Masonry Works, IV) Doors and Windows, V) Plumbing and Tile Works, VI) Electrical Works**. Completion of the Works is required **90 Calendar Days**. Bidders should have completed, within ten (10) years from the date of submission and receipt of bids, a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in.
3. Bidding will be conducted through open competitive bidding procedures using non-discretionary pass/fail criterion as specified in the Implementing Rules and Regulations (IRR) of Republic Act 9184 (RA 9184), otherwise known as the “Government Procurement Reform Act”.

Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least seventy five percent (75%) interest or outstanding capital stock belonging to citizens of the Philippines.

4. Interested bidders may obtain further information from **LGU-San Jose Bids and Awards Committee** and inspect the Bidding Documents at the address given below from **8:00 am to 5:00 pm, Monday to Friday excluding holidays**.
5. A complete set of Bidding Documents may be purchased by interested Bidders on **October 29, 2015 – November 17, 2015** from the address below and upon payment of a nonrefundable fee for the Bidding Documents in the amount of **P 5,000.00**.
6. **The Procuring Entity intends to limit the Pre-Bid Conference to Bidders who have purchased the Bidding Documents;**

The **Local Government Unit of San Jose** will hold a Pre-Bid Conference on **November 5, 2015 at 8:30 A.M. at Mayor’s Office, 2nd floor Municipal Hall Building, San Jose, Camarines Sur**, which shall be open to all interested parties.



Bids will be opened in the presence of the bidders’ representatives who choose to attend at the address below. Late bids shall not be accepted.

8. The **LGU – San Jose, Camarines Sur** reserves the right to accept or reject any bid, to annul the bidding process, and to reject all bids at any time prior to contract award, without thereby incurring any liability to the affected bidder or bidders.
