

Invitation to Bid for

Concreting of Road & Construction of Drainage System

1. **The LGU – San Jose, Camarines Sur**, through the **20% Municipal Development Fund C/Y 2015** intends to apply the total sum of **Five Hundred Forty Thousand Five Hundred Eighty Five Pesos and 63/100 (Php 540, 585.63)** being the Approved Budget for the **Contract (ABC)** to payments under the contract for **Concreting of Road & Construction of Drainage System of Different Barangay of this municipality**. Bids received in excess of the **ABC** shall be automatically rejected at bid opening.
 2. The **Local Government Unit of San Jose** now invites bids for **Concreting of Road & Construction of Drainage System at Barangays Tominawog, Mampirao, San Antonio, Danlog, Sabang, Calawit, & San Juan, San Jose, Camarines Sur with the following scope of works such as; A.) Concreting of Road: I) Sub-Grade Preparation, II) Aggregate Sub-Base Course, III) Portland Cement Concrete Pavement, IV) Construction Safety & Health V) Mobilization/Demobilization; B.) Construction of Drainage System: I) Clearing and Excavation Works, II) Concrete and Masonry Works, III) PCCP Works**. Completion of the Works is required **30 Calendar Days**. Bidders should have completed, within ten (10) years from the date of submission and receipt of bids, a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in.
 3. Bidding will be conducted through open competitive bidding procedures using non-discretionary pass/fail criterion as specified in the Implementing Rules and Regulations (IRR) of Republic Act 9184 (RA 9184), otherwise known as the “Government Procurement Reform Act”.
- Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least seventy five percent (75%) interest or outstanding capital stock belonging to citizens of the Philippines.
4. Interested bidders may obtain further information from **LGU-San Jose Bids and Awards Committee** and inspect the Bidding Documents at the address given below from **8:00 am to 5:00 pm, Monday to Friday excluding holidays**.
 5. A complete set of Bidding Documents may be purchased by interested Bidders on **December 11-18, 2015** from the address below and upon payment of a nonrefundable fee for the Bidding Documents in the amount of **P 1,000.00**.
 6. Bids must be delivered to the address below on or before **8:00 A.M., December 18, 2015 at BAC Office, 2nd floor Municipal Building, San Jose, Camarines Sur**. All bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in ITB Clause
- Bids will be opened in the presence of the bidders’ representatives who choose to attend at the address below. Late bids shall not be accepted.
7. The **LGU – San Jose, Camarines Sur** reserves the right to accept or reject any bid, to annul the bidding process, and to reject all bids at any time prior to contract award, without thereby incurring any liability to the affected bidder or bidders.
