

Invitation to Bid for

Concreting of Farm-to-Market Road

1. **The LGU – San Jose, Camarines Sur**, through the **20% Municipal Development Fund C/Y 2016** intends to apply the total sum of **Three Million Six Hundred Eighteen Thousand Four Hundred Forty Seven Pesos and 22/100 (Php 3,618,447.22)** the Approved Budget for the Contract (ABC) to payments under the contract for **Concreting of Farm-to-Market Road at Mampirao-Bagacay Road Section of this municipality**. Bids received in excess of the ABC shall be automatically rejected at bid opening.

The **Local Government Unit of San Jose** now invites bids for **Concreting of Farm-to-Market Road at Mampirao-Bagacay Road Section, San Jose, Camarines Sur with the following scope of works such as; 100) Clearing/Grubbing, 105) Sub-Grade Preparation, 202) Aggregate Sub-Base Course, 102a) Roadway Excavation (Common), 104) Embankment, 101) Breaking/Removal, 311) Portland Cement Concrete Pavement, SLOPE PROTECTION: A.) Earthworks; A-1) Excavation, B.) Reinforced Concrete Works; B-1) Footing (Reinforced Concrete), B-2) Grouted Riprap: RCPC, A.) RCPC w/ Excavation, SPL-I) Construction Safety and Health, SPL-II) Rental of Bunkhouse/Field Office, SPL-III) Project Billboard, SPL-IV) Mobilization/Demobilization**. Completion of the Works is required **90 Calendar Days**. Bidders should have completed, within ten (10) years from the date of submission and receipt of bids, a contract similar to the Project.  3. Bidding will be conducted through open competitive bidding procedures using non-discretionary pass/fail criterion as specified in the Implementing Rules and Regulations (IRR) of Republic Act 9184 (RA 9184), otherwise known as the “Government Procurement Reform Act”.
- Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least seventy five percent (75%) interest or outstanding capital stock belonging to citizens of the Philippines.

 6. **The Procuring Entity intends to limit the Pre-Bid Conference to Bidders who have purchased the Bidding Documents;**

The **Local Government Unit of San Jose** will hold a Pre-Bid Conference on **January 20, 2016 at 8:00 A.M. at Mayor’s Office, 2nd floor Municipal Hall Building, San Jose, Camarines Sur**, which shall be open to all interested parties.

7. Bids must be delivered to the address below on or before **8:00 A.M., February 1, 2016 at BAC Office, 2nd floor Municipal Building, San Jose, Camarines Sur**. All bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in ITB Clause

Bids will be opened in the presence of the bidders' representatives who choose to attend at the address below. Late bids shall not be accepted.

8. The ***LGU – San Jose, Camarines Sur*** reserves the right to accept or reject any bid, to annul the bidding process, and to reject all bids at any time prior to contract award, without thereby incurring any liability to the affected bidder or bidders.
