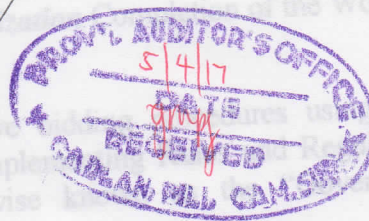

1. The *LGU – San Jose, Camarines Sur*, through the *ADM (Assistance to Disadvantaged Municipality) Fund 2017* intends to apply the total sum of *Two Million Pesos* from the *Approved Budget for the Contract (ABC)* to payments under the *Core Local Access Road at Barangay Calawit, San Jose, Camarines Sur*. Bids received in excess of the *ABC* shall be automatically rejected at bid opening.
2. The *Local Government Unit of San Jose* now in the *scope of* *Access Road at Barangay Calawit, San Jose, Camarines Sur* includes the following works: *100) Clearing/Grubbing, 101) Subgrade Preparation, 202) Aggregate Sub-Base Course, 300) Concrete Works, 311) PCCP, 312) C. SPL; SPL1) Construction Safety and Health, SPL2) Rental of Bunkhouse/Field Office, SPL3) Project Billboard, SPL4) Mobilization/Demobilization*. The Works is required *90 Working Days*.
3. Bidding will be conducted through open competitive bidding. The selection of the lowest responsive and *discretionary pass/fail criterion as specified in the Implementing Rules and Regulations (IRR) of Republic Act 9184 (RA 9184), otherwise known as the Government Procurement Reform Act*.
Bidding is restricted to *Filipino citizen or 75% Filipino-owned partnership, corporation, cooperative or joint venture and must have an experience of having completed, within a period of ten (10) years from the date of submission and receipts of bids, at least one (1) contract that is similar to the contract to be bid costing at least 50% of the ABC.*
Interested bidders may obtain further information from *LGU-San Jose Bids and Awards Committee* and inspect the Bidding Documents at the address given below from *8:00 am to 5:00 pm, Monday to Friday excluding holidays.*
4. A complete set of Bidding Documents may be purchased by interested Bidders on *May 4-23, 2017* from the address below and upon payment of a nonrefundable fee for the Bidding Documents in the amount of *P 5,000.00*.
It may also be downloaded free of charge from the website of the *PhilGEPS* and the website of the *Procuring Entity*, provided that bidders shall pay the non-refundable fee for the bidding documents not later than the submission of their bids.
5. Bids must be delivered to the address below on or before *8:00 A.M., May 23, 2017 at Assessor's Office/BAC Office, Ground Floor Municipal Building, San Jose, Camarines Sur*. All bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in *ITB Clause*.
Bids will be opened in the presence of the bidders' representatives who choose to attend at the address below. Late bids shall not be accepted.
6. *The Procuring Entity intends to limit the Pre-Bid Conference to Bidders who have purchased the Bidding Documents;*
