

INVITATION TO BID FOR the Supply and Delivery of Materials for the Construction of Power House at Hospital Site of Barangay Boclod of this municipality

1. The *Local Government Unit of San Jose*, through the *20% Supplemental Budget C/Y 2017* intends to apply the sum of *One Hundred Thirty Eight Thousand Eight Hundred Thirty Eight Pesos and 10/100 (Php 138,838.10)* being the Approved Budget for the Contract (ABC) to payments under the contract for supply and delivery Materials for the Construction of Power House at Hospital Site of Barangay Boclod of this Municipality. Bids received in excess of the ABC shall be automatically rejected at bid opening.
2. The *LGU-SAN JOSE* now invites bids for the supply and delivery of *MATERIALS FOR THE CONSTRUCTION OF POWER HOUSE AT HOSPITAL SITE OF BARANGAY BOCLD OF THIS MUNICIPALITY*. Delivery of the Goods is required 7 days after receipt of NTP. Bidders should have completed, within 7 days from the date of submission and receipt of bids, a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II. Instructions to Bidders.
3. Bidding will be conducted through open competitive bidding procedures using a non-discretionary "pass/fail" criterion as specified in the Implementing Rules and Regulations (IRR) of Republic Act (RA) 9184, otherwise known as the "Government Procurement Reform Act".

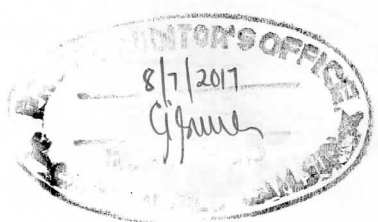
Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines, and to citizens or organizations of a country the laws or regulations of which grant similar rights or privileges to Filipino citizens, pursuant to RA 5183 and subject to Commonwealth Act 138.

4. Interested bidders may obtain further information from *LGU-San Jose BIDS AND AWARDS COMMITTEE, LGU-San Jose, Camarines Sur* and inspect the Bidding Documents at the address given below during *8:00 am to 5:00 pm, Monday to Friday excluding holidays*.
5. A complete set of Bidding Documents may be purchased by interested Bidders on *August 7-14, 2017* from the address below and upon payment of a non-refundable fee for the Bidding Documents in the amount of *Five Hundred Pesos Only (P 500.00)*.
6. Bids must be delivered to the address below on or before *August 14, 2017 at 8:00 A.M.*. All bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in ITB Clause.

Bid opening shall be on *August 14, 2017 at 8:30 A.M. at Assessor's Office/BAC Office, Municipal Building, San Jose, Camarines Sur*. Bids will be opened in the presence of the Bidders' representatives who choose to attend at the address stated above. Late bids shall not be accepted.

7. The *Local Government Unit of San Jose* reserves the right to accept or reject any bid, to annul the bidding process, and to reject all bids at any prior to contract award, without thereby incurring any liability to the affected bidder or bidders.
