The **Local Government Unit of San Jose** now invites interested bidders to submit bids for the following works: I) Clearing/Grubbing, II) Sub-Grade, III) Roadway Excavation (manual), IV) Roadway Excavation (mechanical), V) Concrete Pavement; SLOPE PROTECTION: VI) Earthworks/Structure Excavation, VII) Boulder Fill, IX) Grouted Rip-rap, X) Reinforced Concrete Works, XI) Concrete Breaking, XII) Construction Safety & Health Program, XIII) Rental of Bunkhouse/Field Office, XIV) Project Billboard, XV) Mobilization/Demobilization. Completion of the Works is required 105 Working Days.

Bidding will be conducted through open competitive bidding procedures using non-discretionary pass/fail criterion as specified in the Implementing Rules and Regulations (IRR) of Republic Act 9184 (RA 9184), otherwise known as the "Government Procurement Reform Act".

Bidding is restricted to Filipino citizen or 75% Filipino-owned partnership, corporation, cooperative or joint venture and must have an experience of having completed, within a period of ten (10) years from the date of submission and receipts of bids, at least one (1) contract that is similar to the contract to be bid costing at least 50% of the ABC.
