Invitation to Bid for the Concreting of Farm to Market Road

Del Carmen-Palale, San Jose, Camarines Sur

1. **The LGU – San Jose, Camarines Sur**, through the **20% Local Development Fund 2019** intends to apply the total sum of **Nine Million Four Hundred Twenty Two Thousand One Hundred Fifteen Pesos and 18/100 (Php 9,422,115.18)** being the Approved Budget for the Contract (ABC) to payments under the contract for **Concreting of Farm to Market Road at Barangay Del Carmen – Barangay Palale, San Jose, Camarines Sur**. Bids received in excess of the ABC shall be automatically rejected at bid opening.
2. The **Local Government Unit of San Jose** now invites bids for **Concreting of Farm to Market Road at Barangay Del Carmen – Barangay Palale, Jose, Camarines Sur with the following scope of works such as; I) Clearing/Grubbing, II) Sub-Grade Preparation, III) Aggregate Sub-Base Course, IV) Roadway Excavation (manual), V) Embankment, VI) Portland Cement Concrete Pavement; SLOPE PROTECTION: VII) Earthworks/Structure Excavation, VIII) Grouted Rp-rap, IX) Reinforced Concrete Works, X) Construction Safety & Health Program, XI) Rental of Bunkhouse/ Field Office, XII) Project Billboard, XIII) Mobilization/Demobilization**. Completion of the Works is required **120 Working Days**.
3. Bidding will be conducted through open competitive bidding procedures using non-discretionary pass/fail criterion as specified in the Implementing Rules and Regulations (IRR) of Republic Act 9184 (RA 9184), otherwise known as the “Government Procurement Reform Act”.

Bidding is restricted to Filipino citizen or 75% Filipino-owned partnership, corporation, cooperative or joint venture and must have an experience of having completed, within a period of ten (10) years from the date of submission and receipts of bids, at least one (1) contract that is similar to the contract to be bid costing at least 50% of the ABC.

Interested bidders may obtain further information from **LGU-San Jose Bids and Awards Committee** and inspect the Bidding Documents at the address given below from **8:00 am to 5:00 pm, Monday to Friday excluding holidays**.

4. A complete set of Bidding Documents may be purchased by interested Bidders on **January 18, 2019 – February 6, 2019** from the address below and upon payment of a nonrefundable fee for the Bidding Documents in the amount of **Ten Thousand Pesos only (P 10,000.00)**.

It may also be downloaded free of charge from the website of the PhilGEPS and the website of the Procuring Entity, provided that bidders shall pay the non-refundable fee for the bidding documents not later than the submission of their bids.

5. Bids must be delivered to the address below on or before **8:00 A.M., February 6, 2019** at the **Municipal Planning and Development Coordinator Office, Municipal Building, San Jose, Camarines Sur**. All bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in ITB Clause.
6. Bid opening shall also be held on **February 6, 2019, 8:30 AM and onwards at the Engineering’s Office** of this municipality. Bids will be opened in the presence of the bidders’ representatives who choose to attend at the address below. Late bids shall not be accepted.

7. ***The Procuring Entity intends to limit the Pre-Bid Conference to Bidders who have purchased the Bidding Documents;***

The ***Local Government Unit of San Jose*** will hold a Pre-Bid Conference on ***January 25, 2019 at 8:00 A.M. at Mayor's Office, Engineering's Office, Old RHU Building, San Jose, Camarines Sur***, which shall be open to all interested parties.

8. The ***LGU – San Jose, Camarines Sur*** reserves the right to accept or reject any bid, to annul the bidding process, and to reject all bids at any time prior to contract award, without thereby incurring any liability to the affected bidder or bidders.
