Invitation to Bid for the Concreting of Farm to Market Road

Calalahan, San Jose, Camarines Sur

1. The *LGU – San Jose, Camarines Sur*, through the *20% Local Development Fund C/Y 2022* intends to apply the total sum of *Two Million Five Hundred Six Thousand Four Hundred Sixty Six Pesos (Php 2,506,466.00)* being the Approved Budget for the Contract (ABC) to payments under the contract for *Concreting of Farm to Market Road at Barangay Calalahan, San Jose, Camarines Sur*. Bids received in excess of the ABC shall be automatically rejected at bid opening.
2. The *Local Government Unit of San Jose* now invites bids for *Concreting of Farm to Market Road at Barangay Calalahan, Jose, Camarines Sur with the following scope of works such as; 105a) Sub-Grade Preparation, 200) Aggregate Sub-Base Course, 311) Portland Cement Concrete Pavement, SPLI) Construction Safety and Health Program, SPLII) Rental of Bunk House/Field Office, SPLIII) Project Billboard, SPLIV) Mobilization/Demobilization*. Completion of the Works is required *60 Calendar Days*.
3. Bidding will be conducted through open competitive bidding procedures using non-discretionary pass/fail criterion as specified in the Implementing Rules and Regulations (IRR) of Republic Act 9184 (RA 9184), otherwise known as the “Government Procurement Reform Act”.

Bidding is restricted to Filipino citizen or 75% Filipino-owned partnership, corporation, cooperative or joint venture and must have an experience of having completed, within a period of One (1) years from the date of submission and receipts of bids, at least one (1) contract that is similar to the contract to be bid costing at least 50% of the ABC.

4. Interested bidders may obtain further information from *LGU-San Jose Bids and Awards Committee* and inspect the Bidding Documents at the address given below from *8:00 am to 5:00 pm, Monday to Friday excluding holidays*.

upon payment of a nonrefundable fee for the Bidding Documents in the amount of *Five Thousand Pesos only (P 5,000.00)*.

6. Bids must be delivered to the address below on or before *8:00 A.M., March 16, 2022* at the *Municipal Assessor’s Office, Ground Floor, San Jose, Camarines Sur*. All bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in ITB Clause.
7. Bid opening shall be held on *March 16, 2022, 8:30 AM and onwards at the LIGA Office, 2nd Floor, Old Municipal Building, San Jose, Camarines Sur* of this municipality. Bids will be opened in the presence of the bidders’ representatives who choose to attend at the address below. Late bids shall not be accepted.

8. The *Local Government Unit of San Jose* will hold a Pre-Bid Conference on *March 4, 2022 at 8:00 A.M., LIGA Office, 2nd Floor, Old Municipal Building, San Jose, Camarines Sur*, which shall be open to all interested parties.
9. The *LGU – San Jose, Camarines Sur* reserves the right to accept or reject any bid, to annul the bidding process, and to reject all bids at any time prior to contract award, without thereby incurring any liability to the affected bidder or bidders.
