Invitation to Bid for the Construction of Farm to Market Road

Minor, San Jose, Camarines Sur

1. **The LGU – San Jose, Camarines Sur, through the 20% Local Development Fund C/Y 2022** intends to apply the total sum of **Five Million Pesos (Php 5,000,000.00)** being the Approved Budget for the Contract (ABC) to payments under the contract for **Construction of Farm to Market Road at Barangay Minor, San Jose, Camarines Sur**. Bids received in excess of the ABC shall be automatically rejected at bid opening.
2. The **Local Government Unit of San Jose** now invites bids for **Construction of Farm to Market Road at Barangay Minor, Jose, Camarines Sur with the following scope of works such as; LOCATION A: 105a-A) Sub-Grade Preparation, 200-A) Aggregate Sub-Base Course, 311-A) Portland Cement Concrete Pavement, SLOPE PROTECTION: 103a-A) Earth Works/Structure Excavation (Manual), 505b-A) Grouted Riprap, 405-A) Structural Concrete, 404-A) Reinforcing Steel, 104a-A) Embankment); LOCATION B: 105a-B) Sub-Grade Preparation, 311-B) Portland Cement Concrete Pavement, SPLI) Construction Safety and Health Program, SPLII) Rental of Bunk House/Field Office, SPLIII) Project Billboard, SPLIV) Mobilization/Demobilization**. Completion of the Works is required **120 Calendar Days**.
3. Bidding will be conducted through open competitive bidding procedures using non-discretionary pass/fail criterion as specified in the Implementing Rules and Regulations (IRR) of Republic Act 9184 (RA 9184), otherwise known as the “Government Procurement Reform Act”.

Bidding is restricted to Filipino citizen or 75% Filipino-owned partnership, corporation, cooperative or joint venture and must have an experience of having completed, within a period of One (1) years from the date of submission and receipts of bids, at least one (1) contract that is similar to the contract to be bid costing at least 50% of the ABC.

4. Interested bidders may obtain further information from **LGU-San Jose Bids and Awards Committee** and inspect the Bidding Documents at the address given below from **8:00 am to 5:00 pm, Monday to Friday excluding holidays**.

6. Bids must be delivered to the address below on or before **8:00 A.M., March 16, 2022** at the **Municipal Assessor’s Office, Ground Floor, San Jose, Camarines Sur**. All bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in ITB Clause.
7. Bid opening shall be held on **March 16, 2022, 8:30 AM and onwards at the LIGA Office**.

8. The *Local Government Unit of San Jose* will hold a Pre-Bid Conference on *March 4, 2022 at 8:00 A.M., LIGA Office, 2nd Floor, Old Municipal Building, San Jose, Camarines Sur*, which shall be open to all interested parties.
